During that period, he contributed to the foundation of VOXmobile, a mobile operator (sold to Orange).

Active in multiple non-profit organisations supporting education and entrepreneurship (Junior Achievement Luxembourg), Luxembourg's internet connectivity (www.LUCIX.lu) and Luxembourg's Venture Capital & Private Equity Association (www.LPEA.lu), of which he is a former Chairman.

Jérôme graduated Cum Laude from the University of Louvain, where he obtained a Master of Law. He received his MBA from the Rotterdam School of Management, Erasmus University.

In 2009, after 12 years of VC experience, 7 IPOs and having been through bear and bull cycles, he started his private venture investment vehicle Arenatis Capital.

He co-founded Expon Capital in 2015 to invest in stellar growth portfolio companies like Glovo, Catalyte, Spire, Dott.

He received a Master of Science in Electrical Engineering from Supélec, and graduated summa cum laude from Institut d'Etudes Politiques de Paris (Sciences Po) where he obtained an MBA. He is an Insead and ILA certified director. He is French-Luxembourgish, speaks French, English, Luxembourgish and German.
